These persons appeared recently in the Williams County Common Pleas Court:

Jerry L. Oxender, 51, Pioneer, Ohio pleaded guilty to two (2) counts of Theft of Drugs, each a felony of the fourth degree, and four (4) counts of Theft in Office, each a felony of the fourth degree. Oxender was granted Intervention in Lieu of Conviction which requires that he pay full restitution in the amount of \$2,907.93 to William County Medical Services, complete counseling and drug treatment, refrain from any alcohol consumption, using only prescribed medication as directed by his physician, not hold employment that includes access to controlled substances unless there has been notification to his employer of these offenses. Oxender was further ordered to pay all court costs and supervision fees.

Desiree G. Baker, 24, Edgerton, Ohio was sentenced on the charges of Unauthorized Use of a Vehicle, a felony of the fifth degree and Identity Fraud, a felony of the fifth degree to three (3) years of community control.

Scott L. Ferguson, 41, Bryan, Ohio pleaded guilty to Possession of Cocaine, a felony of the fifth degree. Sentencing is scheduled for April 29, 2008 at 9:00 a.m.

Shannon C. Fischer, 35, Edgerton, Ohio pleaded guilty to Breaking and Entering, a felony of the fifth degree. Sentencing is scheduled for May 1, 2008 at 1:15 a.m.

Scott L. Hopkins, 45, Bryan, Ohio was sentenced on the charge of Domestic Violence, a felony of the fourth degree to three (3) years of community control.

Tommy A. Jones, 30, Montpelier, Ohio pleaded guilty to the charges of Theft, a felony of the fifth degree, Receiving Stolen Property, a felony of the fifth degree, and two counts of Burglary, both felonies of the second degree. Sentencing is scheduled for April 29, 2008 at 8:30 a.m.

Otis McKinsey, Jr., 46, West Unity, Ohio pleaded guilty to Non-Support of Dependents, a felony of the fifth degree. Sentencing is scheduled for April 28, 2008 at 1:15 p.m.

Peter J. Moses, 31, Hudson, Michigan pleaded no contest to the charge of Possession of Cocaine, a felony of the fifth degree. Sentencing is scheduled for April 1, 2008 at 1:45 p.m.

Jimmie L. Pearly, 53, Bryan, Ohio pleaded guilty to Trafficking in Cocaine, a felony of the fifth degree. Sentencing is scheduled for April 29, 2008 at 8:45 a.m.

Jackie L. Rau, 20, Montpelier, Ohio was sentenced on the charge of Burglary, a felony of the fourth degree to two (2) years of community control.

Robert A. Sinkey, Jr., 20, Kunkle, Ohio pleaded guilty to Burglary, a felony of the second degree. Sentencing is scheduled for April 25, 2008 at 10:00 a.m.
