### **January 7, 2010 NEWS RELEASE**

These persons appeared recently in the Williams County Common Pleas Court:

Gene K. Chambers, 40, of Stryker, Ohio, pleaded guilty to the charge of Illegal Manufacture of Drugs (Methamphetamine), a felony of the second degree. He was then sentenced to three (3) years to be served at the Ohio Department of Rehabilitation and Correction.

Marcia E. Cornell, 51, of Bryan, Ohio, pleaded guilty to the charge of Illegal Manufacture of Drugs (Methamphetamine), a felony of the second degree. She was then sentenced to three (3) years to be served at the Ohio Department of Rehabilitation and Correction.

Adam G. Chamberlain, 22, of Montpelier, Ohio, was sentenced on the charge of Operating a Vehicle Under the Influence of Alcohol or Drugs of Abuse, a felony of the fourth degree to a mandatory term or sixty (60) consecutive days plus an addition term of sixteen (16) months, to be served at the Ohio Department of Rehabilitation and Correction.

Michael C. Rupp, 22, of Montpelier, Ohio, was sentenced on the charge of Operating a Vehicle Under the Influence of Alcohol or Drugs of Abuse, a felony of the fourth degree to a mandatory term of one hundred twenty (120) consecutive days plus an additional term of twelve (12) months, to be served at the Ohio Department of Rehabilitation and Correction.

Luke M. Beavers, 27, of Montpelier, Ohio, pleaded guilty to the charge of Telecommunications Harassment, a felony of the fifth degree. Sentencing is scheduled for February 3, 2010 at 10:15 a.m.

Shawn M. Hart, 23, of Bryan, Ohio, pleaded guilty to the charge of Aggravated Assault, a felony of the fourth degree. Sentencing is scheduled for February 1, 2010, at 9:00 a.m.

Andrew D. Hughes, 24, of Bryan, Ohio, pleaded guilty to the charges of Unauthorized Use of a Vehicle, a felony of the fifth degree and Theft, a felony of the fifth degree. Sentencing is scheduled for February 3, 2010, at 10:00 a.m.

Matthew L. Williams, 27, of Bryan, Ohio, pleaded guilty to the charge of Gross Sexual Imposition, a felony of the third degree. Sentencing is scheduled for February 1, 2010 at 10:15 a.m.
