## **NOTICE**

In order to file a complaint for eviction in court, you must first serve a completed copy of the "Termination of Lease and Notice to Leave Premises". Two copies of this Notice are attached.

The instructions to complete the Notice are as follows:

- 1) At the top on item 1, insert the full name of all Lessee(s) and the address of the property.
- 2) In paragraph 2, fill in the date you wish to terminate the lease and evict. THE TERMINATION AND EVICTION DATE MUST BE AT LEAST THREE (3) DAYS AFTER YOU SERVE THE NOTICE.
- 3) Fill in item 5 with the date and time you served the notice. Also check the type of service. (Choice number 1 is the easiest. To do this, simply leave a completed notice at the front door of the premises).
- 4) Print your name and address at the bottom and sign.

After completing the notices in duplicate, serve one copy on Lessee(s) and submit one copy to Bish, Butler & Thompson, Ltd. After you bring the Notice to our office along with a copy of any lease we will prepare and file a complaint in court. (Please complete "Complaint Information" below so we can prepare the complaint.) The case will be set for an eviction hearing that usually occurs in two to four weeks after we file the complaint. When the matter is set for hearing we will send you a letter as to the time and date. You must be present for this hearing.
